SECTION C DESCRIPTIONS AND SPECIFICATIONS

STATEMENT OF WORK

FOR RAPID AIRBORNE MINE CLEARANCE SYSTEM (RAMICS) PROGRAM SUPPORT

1.0 SCOPE

The Naval Surface Warfare Center Panama City Division (NSWC PCD) has a requirement for contractor support to provide Systems Engineering, Program Management, Acquisition, and Integrated Logistics support for the RAMICS program. The program is currently in System Development and Demonstration (SD&D) phase, progressing towards Milestone C and transition to production. The Contractor shall provide those non-personal technical services necessary to perform the tasks identified in the following paragraphs.

2.0 APPLICABLE DOCUMENTS

2.1

- DOD 5100.76-M, Physical Security of Sensitive Conventional Arms, Ammunition, and Explosives (AA&E)
- OPNAV Instruction 5530.13C, Department of the Navy Physical Security Standards for Conventional AA&E)

3.0 REQUIREMENTS

3.1 Program Management Support

3.1.1 Data Management System

The contractor shall maintain and update a Data Management System (DMS) for RAMICS and related Programs for Code A21. In the performance of this task, the Contractor shall be responsible for overnight delivery of critical program documents and materials when NSWCPC shipping is unavailable. The Contractor shall transmit/receive documents and materials up to the secret level to/from other Navy laboratories and contractors. Approximately \$1000 will be required for postage associated with document and material transfers during each base or award period.

The Contractor shall also provide technical support to Code A21 personnel in maintaining a digital library and a File Transfer Protocol (ftp) site for RAMICS. This effort will include creation or collection of digital media for identified documents, creation of new data records in the digital library, and the retrieval/submission of digital data in the SD&D Contractors electronic data interchange (EDI) system. An updated printout of the library contents shall be prepared and delivered quarterly.

3.1.2 Program Meetings/Highlights

The Contractor shall attend weekly RAMICS meetings to report on the status of ongoing tasking. Meetings will be held the first work day of the week. The Contractor shall provide a written input at the meeting and provide technical support to NSWC PC Code A21 personnel in the development of summary meeting minutes and highlights. Meetings are held on the first workday of the week and will take approximately one hour. Summary minutes must be ready for distribution, via e-mail, to all project members and line management by noon on the third workday of the week. Attached to the weekly meeting minutes will be a list containing major meeting dates and/or travel dates. Inputs to this list will be received during the weekly meeting. Deliverables will be in MS Word format.

The Contractor shall also provide hosting & support for on-line meetings such as multi-user conference calls and WebEx. Approximately \$2000 will be required for associated communications costs during each base or award period. In addition, once a month, a specially called OAMCM program meeting will be held. The above requirements will apply. Overtime may be required to provide draft meeting minutes by the next business day. In the event that back-up Contractor support is required, a notice of 24 hours will be given for these meetings.

3.1.3 Kick-Off Meeting

The Contractor shall coordinate and conduct a SOW kick-off meeting within 5 working days of the award of the task order. The Contractor shall provide a Microsoft Project Gantt Chart printout (hard copy) showing all the delivery dates of all CDRL submissions identified in the SOW. The Gantt Chart will also show the times for Government review. Following concurrence at the kick-off meeting, the Contractor shall update the Gantt Chart to reflect deliverables completed or slipped and provide a monthly updated submission.

3.1.4 Briefing Materials

AMCM programs conduct quarterly reviews for our sponsor, PMS 495. In the event that the NSWC PC Visual Arts Branch cannot complete all viewgraph packages (for OAMCM programs) in the required deadline, the Contractor shall prepare top level briefing materials for these quarterly reviews. The view graphs will be prepared in Microsoft Office (PowerPoint) and shall illustrate program accomplishments to date, major problems and issues, and tasks scheduled for completion in the reporting period. There will be approximately 40 viewgraphs per briefing; most will be text but two or three may contain either AutoCad files, scanned images, video clips, or graphics. The Contractor shall prepare the presentations from information provided by the Government (GFI). The Contractor shall provide two electronic files on a CD-ROM disk, four color copies, and ten (10) sets of hard copies for each presentation. In addition, the contractor shall also support the development of other multi-media presentation materials for program events such as static displays and conferences. Approximately \$2,000 in miscellaneous materials (transparency or high gloss paper, color ink cartridges, CD's, sheet protectors, matting, etc.) will be required for presentation development during each base or award period.

3.1.5 Project Tracking

The Contractor shall prepare and maintain Master program Tracking Charts for the RAMICS program. These charts shall be prepared using Microsoft Office (Project or Powerpoint). These charts will document ongoing program tasks, milestones, and issues. The Contractor shall develop a method of tracking progress of each task that will be approved by the Program Manager and shall update the charts or develop new charts bi-monthly. The Government will provide input using Microsoft Project software (200 tasks) as well as hard copy input. Printout will be required to reflect different data calls such as; all tasks for the fiscal year, NSWC PANAMA CITY tasks for the fiscal year, etc. Deliverables shall include one color hard copy or plot. An electronic copy will also be stored in the program library.

3.1.6 Program Documents

The Contractor shall assist NSWCPC in the preparation, tracking, and upkeep of selected programmatic documentation. This will include developing, editing, formatting, and copying programmatic documents for selected program distribution. Distribution will be by E-mail, fax, local guard mail, and commercial carrier. These documents will include: (1) a communications listing of all RAMICS team members, (2) a list of deliverables due to the PEO for the reporting period, (3) Budget Work Breakdown Structure for RAMICS, (4) trip reports, or (5) periodic TDA accomplishment summaries, or (6) program presentations. Estimate that these deliverables shall be updated and delivered bi-monthly.

In addition, the contractor shall also support the development of other multi-media presentation materials for program events such as static displays and conferences. Approximately \$2,000 in miscellaneous materials (transparency or high gloss paper, color ink cartridges, CD's, sheet protectors, matting, etc.) will be required for presentation development.

3.1.7 Program Sponsor Support

The Contractor shall assist Code A21 in the development of inputs to support PMS495, the AMCM program sponsor. Support shall include assistance in documentation and reporting on program acquisition planning and

strategy, POM inputs, WBS/EVMS financial analysis, and Action Item (AI) tracking. An updated printout of either the "Official" or "Working" AI tracking databases shall be prepared and delivered bi-monthly. Acquisition document updates will be delivered in the form of technical memorandum on an as required basis (estimate bi-monthly).

3.2 Training Support

3.2.1 The Contractor shall designate a Training Manager who shall manage all contracted training efforts. The Training Manager shall coordinate the development and integration of courseware and scheduling of instructional services with the designated Weapon System Integration Team (WSIT) (both Sikorsky Aircraft Corporation [SAC] and Lockheed Martin Systems Integration - Owego [LMSI-O]) Training Managers. This effort shall be in accordance with an Associate Contractor Agreement (ACA) that will be entered into with the WSIT (both SAC and LMSI-O). The Training Manager shall participate in the PMA205 MH-60S Training Systems Working Group (TSWG) as an extended member.

3.2.2 The Contractor shall participate in the development of RAMICS training products and instructional services to ensure compatibility with the MH-60S training program. The MH-60S training program is defined as the electronic classrooms and courseware under development/developed for the Navy Fleet Replacement Squadron (FRS) and Naval Air Maintenance Training Group (NAMTRAGRU).

3.2.3 The Contractor shall schedule In-Process Reviews (IPR's) to take place at the Contractor's facility. The contractor shall prepare IPR agendas. The contractor shall prepare IPR minutes that shall serve as official guidance for training content and documentation style. The contractor shall conduct IPR's to include Initial kick-off and 30% review. The 30% IPR shall be conducted no later than 120 days prior to CT Training.

3.2.4 The Contractor shall prepare multiple presentations based on the number of students designated for training. Planned courses include the following:

1. RAMICS Theory of Operation
2. Laser Safety Refresher Course
3. RAMICS Aircraft Emergency Procedures
4. PMAS Operation with RAMICS
5. Significant System Operation Failure Alerts/Events

3.2.5 Contractor furnished training material(s) (courseware) will be required to support DT and WSIT CT training for each of the planned training courses. Graphics will be IT-21 compliant and suitable for export to commercially available Computer Based Training (CBT) authoring packages. The contractor shall deliver training materials in paper and digital format, in accordance with the NAMTRAGRU Training Specification Manual 1540.C1 and NAMEDTRA 130A. Training materials to be developed are:

- Curriculum Outline
- Trainee Guides
- System / Equipment Diagram Sheets
- System / Equipment Color Photos

In addition, the Contractor shall develop initial training materials and documentation to support operator PMA training. The development requirements outlined above will apply.

3.3 Test Event Support

The Contractor shall provide technical support to NSWC PC Code A21 in support of RAMICS Test Events. Estimate

that 1-2 significant program tests (1 week duration each), and 1 major program test (3 weeks duration) will be conducted during each base or award period. Contractor support will include monitoring testing, conducting independent analysis, collecting and analyzing data, supporting NSWC PC analysis and developing test documentation. Overtime is anticipated for each significant and major test event to support data consolidation, back-up, and analysis. The Contractor shall provide technical documentation outlining the results of any analyses conducted. NSWC PC Support Codes will provide the primary materials support to the testing; however, on an emergency basis, the Contractor shall supply parts and equipment necessary to support RAMICS testing and analysis. This amount shall not exceed \$5,000 during each base or award period. These supplies will be used to: (1) repair and support the RAMICS and associated components during testing; (2) packaging and shipment of failed and replacement components; and (3) replace or upgrade laboratory facilities or stock (zip disks, videotapes, camera film, etc.).

Ground Truth Support. The contractor shall provide the equipment, capability and resources to support the development of a method of establishing the precision ground truth of the RAMICS system as needed to support a test event, to be held at Lake Glendora, In, starting on or around 20 Oct 08, and ending 16 Dec 08. The contractor shall develop a three part approach to meeting the Navy's need. The three parts shall be:

1) In-field LLA Position survey: The contractor shall develop and conduct an in-field positional survey of the RAMICS system (TS sensor) when operational to an accuracy of 2cm-rms. The contractor shall specify the time required to perform the survey as part of the provided survey procedure.

2) Static Estimate of LOS Sensors position 7 Orientation: The contractor shall develop and provide the test procedure, estimation accuracy predictions, a stand-alone computer application and checkout, testing, training of on-site government personnel to output the LLA position and NED to LOS orientation of the RAMICS system during the test event.

3) Precision Estimates of Positions & Pointing Vectors: The contractor shall provide off-sight post processing of collected ground truth data in support of the test event to output required LLA, relative positions of sensor to target fiducials and unit vectors from LOS sensor to each target fiducial. The government estimates four post processing occurrences to support the LG test event. Estimate that a minimum of 2 weeks of on-site support at lake Glendora, IN will be required to accomplish this tasking. All hardware, software, and support equipment purchased in support of this tasking shall be delivered to the government, to include but not limited to, ground truth equipment, computer work stations, and analysis tools. All data items to include ground truth procedure, analysis tools, user guides, and analysis assessments developed under this tasking shall be delivered in best commercial practice NLT 10 days following the completion of the test event.

4) Pointing Error Analysis Support. The contractor shall provide the equipment, capabilities and resources to develop and perform detailed analysis of collected ground truth data, system meta data, and processed system imagery data to statistically quantify the pointing accuracy of the RAMICS system in support of the LG test event. The end item used in support of this requirement shall be a data analysis tool (RDAT), and included user guide and on-site training.

3.4 Systems Engineering Analysis Tasks

The Contractor shall provide systems engineering/analysis support to NSWCPC to investigate and define RAMICS and related OAMCM operational and system parameters. Specific tasking could include: analysis and correlation of the proposed SD&D system design with baseline Government documentation, statistical analysis of tactical scenarios, clarification of equipment or platform interfaces, and research into operational concepts and definitions. Additionally, the Contractor shall assist NSWCPC in the development and definition of the Government-Furnished Equipment (GFE) components of the RAMICS system. It is anticipated that several white papers will be generated as a result of this research and analysis. The Contractor shall provide technical documentation outlining the results of any analyses conducted.

The Contractor shall also provide analyses and assessments on issues related to RAMICS target acquisition and tracking, weapon pointing and operation, and engagement effectiveness analysis. Specific tasking could include: support to Government review and analysis of the RAMICS design and operation as it relates to target tracking, assessment, and engagement; support to Government review and evaluation of contractor plans for system integration, test, and/or analysis of integration and test results; support to Government participation in RAMICS technical and/or program status reviews; or support to planning and analysis activities related to Government test and evaluation of the RAMICS system.
